### **Privacy Notice**

Please read this privacy notice carefully because it contains important information about your rights in relation to information about you which we hold.

#### Who we are

Benfleet Conservative Club Ltd (**the Club**) collects, uses and is responsible for certain personal information about you. This means that we are responsible as 'controller' of that personal information for the purposes of General Data Protection Regulation which applies to us accordingly.

### The personal information we collect and use

In the course of running the Club, we collect and retain personal information when you provide it to us. ### How we use your personal information

We process information about you:

The legal bases for this processing are that: it is necessary to enable us to provide membership benefits, to comply with our legal obligations or to achieve legitimate purposes of the Club.

## Who we share your personal information with

We may disclose and exchange information with the Association of Conservative Clubs, Castle Point Conservative Association and law enforcement agencies and regulatory bodies for the above reasons.

### Whether information has to be provided by you, and if so why

You must provide us with this information so that you can be a member of the Club.

# How long your personal information will be kept

We will keep the information during your membership of the Club and for seven years after it ends.

## Your rights

Under the <u>General Data Protection Regulation</u> you have a number of important rights, free of charge. In summary, those include rights to:

- fair processing of information and transparency over how we use your personal information
- access to your personal information and other information which this Privacy Notice aims to give you
- require us to correct any mistakes in your personal information which we hold
- require the erasure of your personal information in certain situations
- receive personal information which you have provided to us, in a structured, commonly used and machine-readable format and to transmit those data to a third party in certain situations
- object at any time to processing of your personal information for direct marketing
- object in certain other situations to our continued processing of your personal information
- otherwise restrict our processing of your personal information in certain circumstances.
